

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

STREET LIGHT CONVERSION-CITY WIDE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$31,100.00 from Tierrasanta Landscape Maintenance and Lighting District Fund 70214 to CIP No. 37-310 STREET LIGHT CONVERSION.

BE IT FURTHER RESOLVED, that the total expenditure not to exceed \$292,900.00 from Gas Tax Fund 30219, CIP No. 37-310 STREET LIGHTING CONVERSION and \$31,100.00 from Tierrasanta Landscape Maintenance and Lighting District Fund 70214, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in CIP No. 37-310 STREET LIGHT CONVERSION.
