
ADOPTED ON AUG 20 1984

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those street and drainage easement deeds of H.G. FENTON MATERIAL COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of July 17, 1980, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR-261390 - / and RR-261390 - 2, granting to said City easements for public street and storm drain purposes in a portion of Lot 3 of Section 2, Township 15 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named FLANDERS DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause both deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
