RESOLUTION NUMBER R- 261401

ADOPTED ON AUG 20 1984

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the vacation of streets and public service easements by City Council resolution; and

WHEREAS, the Resolution of Vacation may provide that the vacation occurs only after conditions required by the legislative body have been satisfied and may instruct the Clerk that the Resolution of vacation not be recorded until until the conditions have been satisfied; and

WHEREAS, the Resolution of Vacation No. R-260423 adopted April 9, 1984, provided that the vacation occur only after the final map for the Horton Canyon Subdivision (TM 82-0381) was approved by Council action; and

WHEREAS, in the event the final subdivision map was not approved by June 1, 1984, the Resolution would become void and of no further force or effect; and

WHEREAS, the Subdivision Board has approved a time extension for the expiration of the Horton Canyon Subdivision map until June 1, 1986; and

WHEREAS, the expiration date for the Resolution of Vacation and the Horton Canyon Subdivision map should coincide; NOW


THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Resolution of Vacation No. R-260423 adopted April 9, 1984, and on file in the office of the City Clerk as Document No. RR- 260423, be and the same is hereby ordered amended as follows: That in the event the final map is not approved by June 1, 1986, this Resolution shall become void and be of no further force or effect.

2. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of the amended resolution, attested by him under seal, to be recorded in the office of the County Recorder.
