BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Right of Way Contract with the STATE OF CALIFORNIA, in connection with the above described property, under the terms and conditions set forth in that Right of Way Contract on file in the office of the City Clerk as Document No. RR-261432.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deeds and a certified copy of this resolution to the Property Director for further handling.
