

WHEREAS, pursuant to that agreement the City was to pay for the actual final costs, less credit for amounts previously paid; and

WHEREAS, the actual final costs exceeded the amount previously paid; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the expenditure in the amount not to exceed \$9,744.37 from contingency funds 39005 CIP 58-020.1 "Bay Route Bikeway," Resolution RR-258403, for the purpose of increasing the amount payable for the cost and maintenance agreement with the Atchison, Topeka and Santa Fe Railway Company, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
