
BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low bid of SOLTEK OF SAN DIEGO for construction of SAN DIEGO JACK MURPHY STADIUM EXPANSION - STADIUM CLUB HVAC/RESTROOMS, in the amount of \$388,793, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. RR-261423.

2. That the Auditor and Comptroller is hereby authorized to increase CIP No. 34-1010, SAN DIEGO JACK MURPHY STADIUM EXPANSION, by \$75,000 from excess interest revenue, plus any additional excess interest revenue that accrues from San Diego Stadium Expansion bond proceeds.

3. That the expenditure of \$75,000 to supplement funds authorized by Resolution No. R-261233 is hereby authorized for the purpose of awarding this contract, and authorizing the Auditor and Comptroller, upon advice of the administering department, to transfer excess funds, if any, to the appropriate reserves.
