WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Criss T. Brainard	Fire	\$3,765	Mr. Brainard is a Fire Fighter in the Suppression Division. He suggested the purchase of one Emergency Medical Technician manual per company, instead of one per individual. This has saved \$12,550.40 in material costs. This is the full award.
Ronald C. Shankles	Police	\$1,830	Mr. Shankles is a Detective in the Narcotics Task Force. He suggested a change in the method of narcotics evidence disposal. This is expected to save \$12,208.00 in the first year in labor costs. This is a partial award pending a 12-month review.
Vincent DeLeva	General Services	\$1,165	Mr. DeLeva is an Electrician Supervisor in the Communications and Electrical Division. He suggested that damaged street light and traffic signal poles be replaced with fiberglass poles. This is expected to save \$7,774.36 in the first year in costs for time and material. This is a partial award pending a 12-month review.
