John R. Crowell	Police	\$ 455	Mr. Crowell was an Evidence Technician at the time this suggestion was submitted. One year ago he suggested the development of an in-house fingerprint powder. One year's experience has shown a savings of \$3,021.24 in material costs. This is the remainder of his award.
Bruce G. Brown Jim A. Toci	Council General Services	\$ 275	Mr. Brown was a Council Representative and Mr. Toci is an Assistant Electrical Engineer in the Communication and Electrical Division. One year ago they suggested disconnecting unnecessary traffic signal heads on one-way streets in the downtown area. One year's experience has shown a savings of \$1,758.55. This is the remainder of the award.
Michael J. Donnelly	Fire	\$ 50	Mr. Donnelly is a Fire Engineer in the B Division. He suggested the fabrication of sheaths for chain saws. This was considered to be a significant safety improvement.
