Veronica M. McCune	General Services	\$ 50	Ms. McCune was an Intermediate Clerk in the Building Division at the time of this suggestion. She suggested the use of small envelopes for mail that can be folded and the use of only the least expensive service for sending Certified mail. This was considered to be a significant operational improvement.
Maria A. Uvalle	Fire	\$ 25	Ms. Uvalle is a Word Processing Operator in the Office Services Division. She suggested the use of green bond paper for drafts, instead of rippletone. This is expected to \$91.20 in the first year in material costs.
Matthew Weathersby	Police	\$ 25	Mr. Weathersby was a Police Officer II in the Public Affairs Division at the time of this suggestion. He suggested a revision in the method of labeling Police evidence. This was considered to be a significant operational improvement.
