RESOLUTION OF FEASIBILITY FOR THE IMPROVEMENT OF LOGAN HEIGHTS BLOCK GRANT ALLEYS AND SEWER MAIN REPLACEMENT CONTRACT NO. 2 UNDER THE PROVISIONS OF THE SAN DIEGO MUNICIPAL CODE AND THE IMPROVEMENT ACT OF 1911.

WHEREAS, the hearings provided for in Resolution of Intention No. R-261128 have been held at the time and place fixed, and all continuances, if any, were duly made and ordered; and

- 1. Each and all oral and written protests and objections, if any, made or filed in the matter are hereby overruled and denied.
- 2. The proposed improvement within the limits mentioned in Resolution of Intention No. R- 261128 is hereby determined to be feasible and that the lands to be assessed therefor will be able to carry the burden of such proposed

assessment, and that the public convenience and necessity require the proposed improvement, and that the Special Assessment Investigation, Limitation and Majority Protest Act of 1931 shall not apply.
