BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. STAR TOOL & SUPPLY CO., 2. GOULD HARDWARE & MACHINERY CO., and 3. SOUTHWEST IND. SUPPLY CORP. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SMALL TOOLS as may be required for the period of one (1) year beginning August 1, 1984 through July 31, 1985, per prices on file in the Purchasing Department, as follows:

1. STAR TOOL & SUPPLY CO. for Section I - Files; Section IV - Pliers and Wrenches; Section V - Shovels; Section VI - Screwdrivers and Misc.; Section VII - Sockets and Socket Wrench Accessories; terms 2% 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period with price increase not to exceed 5% of prices in effect at the end of the initial year.
2. GOULD HARDWARE & MACHINERY CO. for Section II - Miscellaneous; Section III - Hammers and Handles; Section IX - Open, Box and Combination Wrenches; terms 2% 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period with price increase not to exceed 7% of prices in effect at the end of the initial year.
3. SOUTHWEST IND. SUPPLY CORP. for Section VIII - Impact Sockets and Accessories; terms 2% 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period with price increase not to exceed 9% of prices in effect at the end of the initial year.
