BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$25,000.00 from Park Service District Fund 11400, CIP No. 29-483 LINDA VISTA COMMUNITY PARK - CRAFTS ROOM CONSTRUCTION and \$70,000.00 from Park Service District Fund 11403, CIP No. 29-483 LINDA VISTA COMMUNITY PARK - CRAFTS ROOM CONSTRUCTION is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
