BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF CLAIREMONT BIKEWAY IMPROVEMENT.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP No. 58-051.0 CLAIREMONT BIKEWAY IMPROVEMENT to the FY 85 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to submit claims to SANDAG for a total of \$25,000.00 in Local Transportation Funds for the CLAIREMONT BIKEWAY IMPROVEMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$25,000.00 from CIP No. 58-051.0 CLAIREMONT BIKEWAY IMPROVEMENT, Local Transportation Fund 39005 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
