That the expenditure, not to exceed \$36,000.00 from Fund 39005, CIP No. 58-025 PALM AVENUE BIKEWAY, is hereby authorized solely and exlusively for providing funds for said project and related cost, and authorizing the Auditor and Comptroller, advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
