APPROVING MAP OF MISSION VALLEY HEIGHTS

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Douglas C. Paul, a registered civil engineer, entitled "MISSION VALLEY HEIGHTS, being a subdivision of Lot 3 and portions of Lots 2, 4 and 5 of Pueblo Lot 1182 in the City of San Diego, County of San Diego, State of California, according to the partition map of said Pueblo Lot 1182 made in an action in the Superior Court of the State of California, in and for said County of San Diego, No. 6481, entitled William A. Conn vs. William D. Whipple, et al., on file in the office of the County Clerk of said San Diego County, which are included within the boundaries of the southwest quarter and the west half of the southeast quarter of said Pueblo Lot 1182, as said Pueblo Lot is shown on the map made by James Pascoe in 1870, and a portion of Lot 2 of the Partition of a portion of Pueblo Lots 1173 and 1174 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Licensed Surveyor's Map No 170, and a portion of Pueblo Lot 1173 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, shown as Lot 1 on Licensed Surveyor's Map No. 170, and a portion of that strip of land shown as Murray Canyon Road lying between Lots 1 and 2 of Licensed Surveyor's Map No. 170, and a portion of Lots 1174 and

1181 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the the following: Murray Canyon Road, Metropolitan Drive, Mission Valley Road, Mission Valley Court and a portion of Mission Center Road, and said streets and portion of a street are hereby declared to be public streets and a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication a portion of Lot 7 marked "Reserved for Future Streets," as shown on this map, under the provisions of Section 66440 of the Government Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraph 1 of the Owner's Certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets and a portion of a street are accepted on behalf of the public as heretofore stated, and that the easements listed in


