
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an amendment to the subdivision agreement for RANCHO CARMEL UNIT NO. 2, on file in the office of the City Clerk as Document No. RR-256272, to provide for the substitution of CARMEL MOUNTAIN RANCH for SHAPPELL-CARMEL MOUNTAIN EAST PARTNERSHIP, as subdivider.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by April 26, 1985, as provided by the amendment to the subdivision agreement, on file in the office of the City Clerk as Document No. RR- 261480 .

BE IT FURTHER RESOLVED, that performance bonds No. 13 03 68 and 13 03 69, issued by INSURANCE COMPANY OF THE WEST, in the total amount of \$3,734,175.00 are hereby accepted as the surety for the required improvements in said subdivision, and substituted as Exhibit "C" to the aforesaid agreement and that performance bond No. 59 SB 020862 BCA, issued by THE AETNA CASUALTY AND SURETY COMPANY, in the amount of \$11,669,299.00, is hereby released.
