1. That the alley within Block 5, Culverwell's Addition, Map 143, as more particularly shown on Drawing No. 16240-B on file in the office of the City Clerk as Document No. RR- $\frac{261484}{}$,

which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.




