

RESOLUTION NUMBER R- 261494

ADOPTED ON SEP 10 1984

WHEREAS, existing federal law does not provide a comprehensive system of assistance to state and local governments to aid them in narcotics enforcement and drug abuse prevention and treatment; and

WHEREAS, H.R. 5990 (Rangel, D-N.Y.) - State/Local Narcotics Assistance Act of 1984, authorizes \$750 million annually for fiscal years 1986 through 1990 to help states and localities increase their efforts to control drug abuse and drug trafficking; and

WHEREAS, upon application by the governor of a state, the bill authorizes the Attorney General to make grants to states on a 90% federal - 10% local cash match basis for the following purposes: providing additional personnel, equipment and facilities for state and local enforcement units; providing similar support to state prosecutors and courts to increase the prosecution and speed up the adjudication of narcotics cases; increasing the capacity of state correctional facilities to hold convicted drug felons, establishing and improving drug treatment and rehabilitation services for offenders; and providing increased support to state efforts to eradicate illicit drug cultivation; and

WHEREAS, on August 13, 1984, the Rules Committee considered the matter, as set forth in the legislative analysis contained in

Intergovernmental Relations Department (IRD) Report No. 84-51;
and

WHEREAS, IRD Report No. 84-51 recommended that the City
resolve to support the proposed federal bill; and


WHEREAS, after consideration of all information provided in
respect to H.R. 5990, the Rules Committee recommended adoption of
a resolution of support by a 4 - 0 vote; and

WHEREAS, the Rules Committee now forwards the matter to the
full Council for action upon that recommendation; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that
this Council, after consideration of IRD Report No. 84-51 and the
action of the Rules Committee in respect thereto, does hereby
express and declare its support for H.R. 5990 (Rangel, D-N.Y.) -
State/Local Narcotics Assistance Act of 1984.
