BE IT RESOLVED, by the Council of the City of San Diego, that the City Council supports the Metropolitan Water District (MWD) endorsed changes to Section 135 of the MWD Act described in Intergovernmental Relations Department (IRD) Report No. 84-49 dated August 7, 1984, on file in the office of the City Clerk as Document No. RR-261495 .

BE IT FURTHER RESOLVED, that the City Council encourages the San Diego County Water Authority (SDCWA) to seek an additional imported water supply independent from MWD if said legislation is not adopted.

BE IT FURTHER RESOLVED, that the City representatives to SDCWA are directed to examine alternative sources of water and report to the Rules, Legislation and Intergovernmental Relations Committee within the next quarter.
