WHEREAS, on January 23, 1984, the Rules Committee, as part of the approval process for an Urban Development Action Grant (UDAG) for the U.S. Grant Hotel, directed the CDS Grant Corporation, through the City Manager, to report quarterly on its progress in meeting the UDAG hiring goals; and

WHEREAS, the City Manager in his Report No. 84-240, dated June 20, 1984 provided such quarterly report with input from and assistance of the CDS Grant Corporation; and

WHEREAS, the Rules Committee Consultant Analysis 84-15, dated August 13, 1984, provided updated information in respect to this quarterly report; and


