quarterly night City Council meeting scheduled for September 11, 1984 shall be conducted at the Oaks North Community Center, 12578 Oaks North Drive, San Diego, California 92128 (in the Rancho Bernardo area), said meeting scheduled to commence at 7:00 p.m.
