1. That the City Manager be and he is hereby authorized and empowered to pay the total sum of \$25,000.00 in the settlement of Superior Court Case No. 510843, Carlo Micheletti and Dolores Micheletti v. City of San Diego, et al., and of each and every claim against The City of San Diego, its agents and employees, resulting from the alleged personal injury claims of Carlo Micheletti and Dolores Micheletti.

2. That the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$25,000.00, made payable to Carlo Micheletti and Dolores Micheletti and their attorney Boris E. Efron, in full settlement of the lawsuit and of all claims.


