ADOPTED ON SEP 10 1984

WHEREAS, the 7th Annual Heart of San Diego Marathon and 10,000 meter Fun Run for the American Heart Association, San Diego County Chapter, is to be held on Sunday, November 4, 1984; and

WHEREAS, the race is to start in the City of Coronado and proceed over the San Diego-Coronado Bay Bridge following a scenic marathon route along the bay and finishing in San Diego Stadium; and

WHEREAS, the Department of Transportation, State of California (CALTRANS) has asked the City Council of The City of San Diego to adopt a resolution requesting that CALTRANS close or partially close the San Diego-Coronado Bay Bridge to allow for the running of the race; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that CALTRANS is hereby requested to close or partially close the San Diego-Coronado Bay Bridge on Sunday, November 4, 1984 to allow for the running of the 7th Annual Heart of San Diego Marathon and 10,000 Meter Run.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to contact store owners along the route regarding the event for traffic purposes.
