BE IT RESOLVED, by the Council of The City of San Diego, that the Personnel Director be and he is hereby authorized and empowered to execute, for and on behalf of said City, a SECOND AMENDMENT TO AGREEMENT with INDUSTRIAL MEDICAL CENTERS, to provide pre-employment physical examinations and other medical services at the same rates as Fiscal Year 1984, under the terms and conditions set forth in the SECOND AMENDMENT TO AGREEMENT on file in the office of the City Clerk as Document No. RR- 261517.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$82,000, to be comprised of \$72,000 from General Fund (Fund 100), \$6,000 from Water Operating Fund (Fund 41500) and \$4,000 from Equipment Division Operating Fund (Fund 50030), is hereby authorized, for the sole and exclusive purpose of providing funds for the above program.
