## RESOLUTION NUMBER R-261524 ADOPTED ON September 10, 1984

WHEREAS, the Regional Youth Employment Program (REGY) has been operated by The City of San Diego for the last ten years; and

WHEREAS, prior to 1975, the REGY program was operated by the San Diego Urban League; and

WHEREAS, at the time the City assumed the REGY program, there were few youth employment providers and the REGY program initially covered most of San Diego County; and

WHEREAS, today there are numerous providers and the REGY program has been reduced to the metropolitan portions of San Diego City; and

WHEREAS, because of changing legislation, reduced funding availability, high administrative costs, staffing difficulties and because there are now numerous providers, the need for continued City involvement as a direct provider of youth employment services should be reevaluated; and

WHEREAS, the problems of changing legislation, uncertain funding levels, and annual employee turnover makes it difficult to administer grant contracts through the RETC program and the numerous community-based organizations may be able to provide the same services at a lower cost and with greater administrative ease; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to take the necessary steps to maintain the City's participation in providing jobs by streamlining the Regional Youth Employment Program (REGY) to make it competitive in order that the City's participation in providing jobs is maintained.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to submit the complete proposal to the Rules Committee for its review prior to submitting it to the Regional Employment and Training Consortium (RETC).
