WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of the improvement of City Heights Block Grant Streets and Alleys - Contract No. II, under Resolution of Intention No. R-259022, adopted August 8, 1983, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The assessments described in the Street Superintendent's Assessment No. 3989, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the expenditure of an amount not to exceed \$15,480.82 from Fund 18517, Department 5988, Organization 8807 (CDBG Funds), is hereby authorized, solely and exclusively for the purpose of making the contributions on behalf of the eligible property owners within the district.
