BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP No. 35-065 CENTRAL LIBRARY WINDOW AREA RECONSTRUCTION to the FY 1985 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$23,600.00 from CIP No. 37-000.1 ANNUAL ALLOCATION-MINOR PUBLIC WORKS IMPROVEMENTS and \$4,000.00 from Department 532, Job Order 002501, Organization No. 010, Program Element 53220 to CIP No. 35-065 CENTRAL LIBRARY WINDOW AREA.
