RESOLUTION NUMBER R- 261561

ADOPTED ON SEP 17 1984

APPROVING MAP OF CENTERPOINTE.

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Stuart Peace, a registered civil engineer, entitled "CENTERPOINTE, being a subdivision of Pueblo Lots 308 and 309 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of the County Recorder of San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 36, and a portion of Lot 1 in Block 342, of Old San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of the County Recorder of San Diego County, December 12, 1921, and is known as Miscellaneous Map No. 40; together with a portion of Greenwood Street, lying between said Pueblo Lot 308 and said Block 342 of Old San Diego, as vacated and closed to public use on May 9, 1967, by Resolution No. 190337 of the Council of The City of San Diego, a copy of said Resolution being recorded May 12, 1967 as File No. 67542; together with a portion of Greenwood Street, as closed and vacated to public use; all being in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Greenwood

Street, Moore Street and Sherman Street, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for general utility purposes over, under, upon and across a portion of Lot 2, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated, and that the easement for general utility purposes, as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
