BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF MIRA MESA COMMUNITY PARK FENCING.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP No. 29-543 MIRA MESA COMMUNITY PARK FENCING to the FY 85 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$14,000.00 from Park Service District Fund 11220 to CIP No. 29-543 MIRA MESA COMMUNITY PARK FENCING.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$14,000.00 from CIP No. 29-543 MIRA MESA COMMUNITY PARK FENCING is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
