

RESOLUTION No. R-261604

(R- 85-463)

Adopted on OCT 1 1984

BE IT RESOLVED, by the Council of The City of San Diego as follows:

WHEREAS, the Council of The City of San Diego finds there is a need to provide access for handicapped persons to the second floor of exhibit space in the MUSEUM OF MAN located in Balboa Park; and

WHEREAS, the MUSEUM OF MAN has generously offered to donate the sum of \$30,000.00 to supplement an \$87,800.00 donation previously accepted per Resolution No. R-261167, adopted on July 16, 1984, to the City for the purpose of making the necessary improvements to the MUSEUM OF MAN in order to provide the access; and

WHEREAS, the MUSEUM OF MAN'S donation is in the form of an Irrevocable Letter of Credit drawn on the San Diego Trust and Savings Bank, San Diego, California (documentary credit No. 40720), a copy of which is on file in the office of the Clerk of the City as Document No. RR-261604 and

WHEREAS, the rehabilitation improvements to the MUSEUM OF MAN will be made conditioned upon receipt of the donated funds from the MUSEUM OF MAN; and

WHEREAS, upon receipt of the funds from the MUSEUM OF MAN, the Auditor and Comptroller of the City shall place these funds in the Private Contribution Trust Fund 63022, to be used solely and exclusively for the purpose of paying for the above-described improvements to the MUSEUM OF MAN; NOW, THEREFORE,

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the generous donation of the sum of \$30,000.00 in the form of an Irrevocable Letter of Credit, from the MUSEUM OF MAN for the purpose of assisting the financing of the rehabilitation of said Museum is hereby accepted with deep gratitude for and on behalf of the people of The City of San Diego.

BE IT FURTHER RESOLVED, that the city Auditor and Comptroller be, and he is hereby authorized and directed to place these funds in the Private Contribution Trust Fund 63022, to be used solely and exclusively for the purpose of paying for the above-described improvements to the MUSEUM OF MAN.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to return to the MUSEUM OF MAN any funds attributable to the generous donation by the Museum which remain unexpended or unencumbered in Trust Fund 63022 after completion of the above-described improvements.
