BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of CARUS CHEMICAL COMPANY, DIVISION OF CARUS CORPORATION is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of an ESTIMATED TWO HUNDRED THOUSAND FOUR HUNDRED THIRTY-FOUR (200,434) POUNDS OF POTASSIUM PERMANGANATE FREE FLOWING CAIROX as may be required for a period of one (1) year beginning November 1, 1984 through October 31, 1985, at a cost of \$0.9406 per pound for a total estimated cost of \$188,528.22; terms net 30 days, plus sales tax, plus an estimated freight charge of \$12,907.95.
