DEVELOPMENT OF CALIFORNIA, INC., all the City's right, title and interest in the drain easement, as more particularly described in said quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
