BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those street easement deeds of BETTY JAGGER, dated June 18, 1984; J.M. LUNA and LENA LUNA, dated June 18, 1984; and PARDEE CONSTRUCTION COMPANY, a California corporation, dated May 23, 1984, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents Nos. RR- 261634 -1, RR- 261634 -2 and RR- 261634 -3, granting to said City easements for public street purposes in a portion of the Southeast Quarter of the Northwest Quarter, Section 18, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named QUARTER MILE DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
