RESOLUTION NUMBER R- 261651

ADOPTED ON OCT 1 1984

WHEREAS, by Resolution No. R-260238 adopted on March 5, 1984 this Council approved and authorized the City Manager to execute an Option Agreement between The City of San Diego (the "City") and VillaView Community Hospital (the "Hospital"), which Option Agreement was executed as of April 1, 1984; and

WHEREAS, in Articles II and III of the Option Agreement the Hospital has granted the City an option to require the Hospital to repurchase the Hospital facilities for the sum of \$758,000, and that the value of certain services to be provided by the Hospital to the City, as agreed between the parties, shall be credited against said sum; and

WHEREAS, the City intends to exercise its rights under the Option Agreement, and the City and the Hospital have agreed upon the nature of services to be rendered, as set forth in a Health Services Agreement between the parties; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the form of Health Services Agreement on file in the office of the City Clerk as Document No. RR-261651 is hereby approved and the City Manager is hereby authorized on behalf of the City to execute and accept the aforesaid Services Agreement.

BE IT FURTHER RESOLVED, that the City Manager is hereby instructed to exercise the option of the City set forth in the Option Agreement, and to transfer the Hospital facilities to the

Hospital upon receipt of evidence satisfactory to the City
Manager with respect to a Center for the Aging, all as is defined
in the Option Agreement.
