Harvey T. Gilbreath	Utilities	\$ 1,620	Mr. Gilbreath is a Plant Maintenance Mechanic in the Metro Wastewater Division. He suggested the drilling of 1/8 inch grease zert holes in the scum skimmer flights. This is expected to save \$10,786.51 in labor and equipment costs. This is a partial award pending a 12-month review.
Hubert Tipton	General Services	\$ 510	Mr. Tipton was a Utilityman I in the Communication and Electrical Division at the time this suggestion was submitted. He suggested the replacement of glass street light globes with plastic ones. This is expected to save \$3,390.30 in the first year in costs for time, material and equipment. This is a partial award pending a 12-month review.
Vincent DeLeva	General Services	\$ 500	Mr. DeLeva is an Electrician Supervisor in the Communication and Electrical Division. One year ago he suggested the replacement of the 400 watt metal halide lamps used in lighting fixtures with 300 watt halide lamps. One year's experience has shown a savings of \$2,705.76. This is the remainder of his award.
