Archie R. Steel	General Services	\$ 180	Mr. Steel is a Painter in the Buildings Division. He suggested the utilization of damaged scaffold. This is expected to save \$594.48 in material costs.
Gene P. Hollar	General Services	\$ 150	Mr. Hollar is an Equipment Mechanic in the Equipment Division. He suggested the cutting of an access door in the rear of Heil trash trucks. This was considered to be a significant safety improvement.
Ida E. Cunradi	Police	\$ 50	Ms. Cunradi was an Intermediate Typist in the Records Division at the time she submitted this suggestion. She suggested that San Diego Data Processing be requested to convert the computer printer to cartridge ribbons. Actual savings are \$51.19, but the department has recommended an intangible award based on anticipated operational improvement.
