Joseph T. Flynn	Planning	\$ 50	Mr. Flynn is the Zoning Administrator. He suggested a modification of the name plate rack in Council Chambers. This was considered to be a significant safety improvement.
Robert M. Hopkins	Utilities	\$ 50	Mr. Hopkins was an Equipment Technician II in the Metro Wastewater Division at the time of this suggestion. He suggested the installation of a row of 110 outlets along the tanks at the Point Loma Wastewater Plant. This was considered to be a significant safety improvement.
Paul Rabik	Police	\$ 50	Mr. Rabik is a Motive Service Technician in the Western Division. He suggested the moving of Police Department car wash posts back one foot. This was considered to be a significant safety improvement.
