<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Joseph R. Rogers	Fire	\$ 50	Mr. Rogers is a Fire Engineer in Division C. He suggested the discontinuance of printing mapbook changes for reserve apparatus. This was considered to be a significant operational improvement.
Jack A. Salfen	Utilities	\$ 50	Mr. Salfen is a Wastewater Plant Lead Operator in the Metro Wastewater Division. He suggested the provision of trash buckets for dewatering pumps at Point Loma Wastewater Plant. This was considered to be a significant operational improvement.
Rita R. Chinneck	Utilities	\$ 25	Ms. Chinneck was a Water Plant Operator in the Quality Division at the time she submitted this suggestion. She suggested that the valves controlling the Lakeside remote control valves be reset on an automatic system. This suggestion led directly to the installation of phase reverse relays which resulted in actual savings of \$82.65.
