BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$56,000.00 of Environmental Growth Funds (10505) from CIP No. 20-010 ANNUAL ALLOCATION - RESOURCE BASED OPEN SPACE PARKS to CIP No. 29-466 LOS PENASQUITOS CANYON PRESERVE - IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$68,100.00 from Environmental Growth Funds (10505) CIP No. 29-446 LOS PENASQUITOS CANYON PRESERVE - IMPROVEMENTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
