ADOPTED ON OCT 8 1984

WHEREAS, Parcel #548-450-15 was abated in 1983 with charges totalling \$153.12; and

WHEREAS, the property owner of that parcel, Edward C. Smart, did not receive a notice of his right to appeal to the Council on the costs or of the Council hearing on the costs held on November 14, 1983, because of a mailing discrepancy; and

WHEREAS, the Council confirmed the costs of abatement on Parcel #548-450-15 by Resolution No. R-259616 without knowing that the property owner had not received notice of the Council's hearing; and

WHEREAS, the Council is desirous of granting Edward C. Smart an opportunity to be heard on the costs of abating Parcel #548-450-15 in 1983; NOW THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the report of the Fire Chief showing the cost of weed abatement against each parcel of land in the City Manager's Report No. 83-460 of November 8, 1983, as confirmed by Resolution No. R-259616, as previously revised and amended, be and is hereby amended.
2. That the assessment of Parcel No. 548-450-15 in the amount of \$153.12 be and is hereby deleted from the City Manager's Report No. 83-460.

3. That the 1983 abatement costs of \$153.12 against Parcel #548-450-15 be considered at the Council's hearing on the costs of weed abatement in 1984, as shown in City Manager's report No. 84-392, on Weed Abatement Cost Confirmation 1984.

4. That the City Clerk is hereby directed to forward a certified copy of this resolution with a copy of amended City Manager's Report No. 83-460 to the Office of County Auditor.
