BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP No. 31-140 MONTGOMERY FIELD NOISE MONITORING SYSTEM to the FY 1985 Budget.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$250,000.00 from the Unallocated Reserve (Dept. 720, Object Account 4220, Job Order 25001) to CIP No. 31-140 MONTGOMERY FIELD NOISE MONITORING SYSTEM.
