WHEREAS, the Council of The City of San Diego held a public hearing to consider the amendment to the OTAY MESA-NESTOR COMMUNITY PLAN; and

WHEREAS, the Council of The City of San Diego, by majority vote, approved the amendment of the OTAY MESA-NESTOR COMMUNITY PLAN; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That this Council hereby approves the amendment to that plan entitled OTAY MESA-NESTOR COMMUNITY PLAN, by the incorporation therein of THE HEIGHTS BY ROBINHOOD, a copy of which plan is on file in the office of the City Clerk as Document No. R-261710.
- 2. That the amendment to the OTAY MESA-NESTOR COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plans, an omnibus hearing on this and other amendments having been scheduled on or about December 1984.
