SERVICE is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF TWO (2) FIRE STATIONS as may be required for a period of one (1) year beginning October 16, 1984 through October 15, 1985 for a total cost of \$10,800.00; terms 3% 20 days; with an option to renew contract for two (2) additional one (1) year periods, with no escalation the first option year and an escalation not to exceed 5% of bid prices the second option year.
