BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$5,000.00 from Capital Outlay Fund 30245, CIP No. 62-226 TORREY PINES ROAD AT HIDDEN VALLEY ROAD and \$48,000.00 from Revenue Sharing Fund 18013 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
