BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of street, water and flowage easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of February 24, 1984, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 261732 - 1, RR- 261732 - 2 and RR- 261732 - 3, granting to said City street, water and flowage easements in a portion of Section 16, Township 14 South, Range 2 West, San Bernardino Meridian, and in a portion of Rancho de los Penasquitos, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and the same are hereby named EVENING CREEK DRIVE NORTH and EVENING CREEK DRIVE SOUTH.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
