BE IT RESOLVED, by the Council of the City of San Diego, that Resolution No. R-261143 adopted on July 9, 1984, be and the same is hereby amended to read as follows:

1. That the City Manager be and he is hereby directed not to allow the transfer of taxicab permits from and after passage of this resolution until the effective date of Ordinance No.

O- 16311 (Attorney's No. O-85-12 (Rev.)).

2. That beginning on the effective date of Ordinance No.

O- 16311 (Attorney's No. O-85-12 (Rev.)), the City Manager shall process those applications for transfer of permits received by the City Manager on or before the moratorium on transfers was first established by Resolution No. R-258870 adopted on July 11, 1983, and those applications received by the City Manager from July 11, 1983, through 12 noon October 15, 1984, in accordance with the criteria set forth in Chapter VII, Article 5, of the Municipal Code existing as of October 15, 1984.
