BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with the STATE DEPARTMENT OF HEALTH SERVICES, under which agreement City agrees to assume responsibility for development on the former Mission Bay landfill site, including the proposed Ramada Renaissance hotel, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to expend an amount not to exceed \$50,000 (\$25,000 from CIP 37.250; \$25,000 from the General Fund Unallocated Reserve) for monitoring services by the County of San Diego related to development of the site.

BE IT FURTHER RESOLVED, that the effectiveness of this resolution is contingent upon the City Manager obtaining an agreement from Ramada Renaissance hotel acknowledging the fact that the property in question was a landfill site and agreeing that the City will not be held responsible for foreseeable problems which may result from the fact that the site was used as a landfill in the past.
