Advanced Life Support (ALS) Rates

Base Rate/Response	\$210/incident
Mileage (pick up to hospital)	\$5/mile
Oxygen Administered	\$15/patient where applicable
Consumable Supplies/Drugs*	Per current rates
Night Charge (7 p.m. to 7 a.m.)	\$15/patient where applicable
Multi-Patient Rate	When there are two or more patients, 80% of the base rate is charged to each patient. Above charges other than base rate are charged at 100%.

Basic Life Support (BLS) Rates

Base Rate/Response	\$75/incident
Mileage (pick up to hospital)	\$5/mile
Code 3 Response	\$15/incident where red light and/or siren used
Electro-Cardiogram (EKG)	\$20/patient where applicable
Oxygen Administered	\$15/patient where applicable
Telemetry Used	\$25/patient where applicable
Consumable Supplies/Drugs*	Per current rates
Night Charge (7 p.m. to 7 a.m.)	\$15/patient where applicable
Waiting Time	\$15/15 minute period or fraction thereof where applicable
Multi-Patient Rate	When there are two or more patients, 80% of the base rate is charged to each patient. Above charges other than base rate are charged at 100%.
