

RESOLUTION NUMBER R- 261777

ADOPTED ON OCT 22 1984

WHEREAS, the November 1984 State General Election Ballot includes sixteen statewide propositions; and

WHEREAS, said statewide propositions are numbered consecutively as Propositions 25 through 41; and

WHEREAS, summaries and recommendations for each proposition are provided by the Department of Intergovernmental Relations in its IRD Report No. 84-60, dated October 2, 1984; and

WHEREAS, the Rules Committee reviewed the various propositions at its meeting of October 8, 1984 and determined to make recommendations to the full Council on five of the sixteen statewide propositions; and

WHEREAS, the Rules Committee now forwards the matter to the full City Council with a recommendation that the full City Council support Propositions 25, 27, 29, 30 and 39 as summarized in IRD Report No. 84-60; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Rules Committee recommendations in respect to Propositions

25, 27, 29, 30 and 39 on the November 1984 State General Election  
Ballot, be and the same are hereby approved and adopted.

BE IT FURTHER RESOLVED, that the City Council opposes  
Proposition 41.
