WHEREAS, on September 10, 1984, the Governor signed AB 2279 (Mojonnier) which directs CALTRANS to establish a task force to review the future needs of the San Diego-Coronado Bridge and alternative transportation solutions to bridge-related traffic impacts after payment of all outstanding bonds; and

WHEREAS, the task force will be composed of representatives from the cities of San Diego and Coronado, CALTRANS, the San Diego Association of Governments, the San Diego Metropolitan Transit Development Board and possibly the United States Navy and is required to report its findings and recommendations to the Legislature by July 1, 1985; and

WHEREAS, the first meeting of the task force will be held on October 30, 1984; and

WHEREAS, the Intergovernmental Relations Department, in IRD Report No. 84-63, dated October 19, 1984, provided a report and recommendation on the San Diego-Coronado Bridge Task Force; and

WHEREAS, said report was heard and considered by the Rules Committee on October 22, 1984; and

WHEREAS, the Rules Committee on that date voted 4-0 to approve and adopt said recommendation and to appoint a representative and alternate to said task force; and

WHEREAS, the Rules Committee now forwards the matter to the full Council for approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby expresses support for the establishment of a San Diego-Coronado Bridge Task Force.

BE IT FURTHER RESOLVED, that the Rules Committee's recommendation that Mayor Roger Hedgecock be appointed the City's representative to the task force, Councilmember Dick Murphy be appointed as alternate, and that the City Manager provide staff support, be and the same is hereby approved and adopted.
